1. Information Collected

1.1 Personal Information

1.2 Technical Information

The website may automatically collect:

IP address

2. Purpose of Collection and Use

Maintaining internal communication and compliance records

Personal information is not used for unsolicited communications.

3. Legal Basis for Processing

4. Disclosure of Information

The Company does not sell, rent, or trade personal information.

Information may be disclosed only to:

Authorized personnel of the Company for communication and inquiry resolution

Technology service providers (including hosting, email, and communication platforms) strictly for operational purposes

Governmental, regulatory, or legal authorities when required by law

All third parties are required to maintain appropriate confidentiality and data protection standards.

5. Cookies

The website uses cookies to:
